- The figures in Boxes 3 to 6 for the current and prior years have been stated gross of VAT. These should be stated net of VAT
 as the smaller authority prepares its AGAR on an income and expenditure basis.
- As a result of the above matters, the figures in Section 2, Boxes 3 and 6 for the prior year should read £60,424 and £93,905 respectively, and Boxes 2, 3 and 6 for the current year should read £77,251, £27,383 and £46,819 respectively.
